

Business is a calling





Noble Calling

"Business is, bar none, the best real hope of the poor. And that is one of the <u>noblest</u> callings inherent in business activities: to <u>raise up the poor</u>." (Novak, 1996, p. 37).

Summoned by God

"If one were *called* to business that person would not only be allowed to work in an enterprise as an acceptable human occupation, but actually *summoned by God* to this work to fulfill God's will and purpose." (Stevens, p. 21).

Three elements of a call

Calling involves *belonging* to God (a relationship), *being* (a way of life) and *doing* (serving God and God's purposes).

- R. Paul Stevens (pp. 21-22).

Business = "to create" and "meaning"

 Business is a way of creating meaning for human beings



Frederick Hart's ex nihilo



What are the purposes of work?

- E.F. Schumacher offers us three purposes of human work:
 - 1. To provide necessary and useful goods and services
 - 2. To enable everyone of us to use and thereby *perfect* our gifts like good stewards
 - 3. To perfect gifts in service to, and in cooperation with others, so as to liberate ourselves from inborn egocentricity.

The Christian in business

"What would happen if Christians in business understood their day-today work— analyzing spreadsheets, making sales calls, preparing a branding campaign, purchasing supplies, tracking inventory—as God's work? Work that contributes to the call that God gave to his people at creation. Work that has part in God's ministry of reconciliation." (Van duzer, p. 199).

Concluding thought...

"Business is a demanding vocation, and one is not good at it just being in it, or even by making piles of money. The bottom line of a calling is measured by pain, learning, and grace." (Novack, p. 14).
